

TriGreen Grocery Giveaway Contest Rules:

The following are the official rules of TriGreen Equipment, LLC (“Sponsor”) for the TriGreen Grocery Giveaway contest (“Contest”). By participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN.** Void where prohibited by law. All federal, state, and local regulations apply.
2. This Contest is open only to legal U.S. residents age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in Tennessee, Alabama, or Dade and Chattooga counties in Georgia. Employees of TriGreen Equipment, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, and the immediate family members and household members of all such employees are not eligible to participate. The term “immediate family members” includes spouses, parents and stepparents, siblings and stepsiblings, and children and stepchildren. The term “household members” refers to people who share the same residence at least three (3) months out of the year. Entrants may not use an assumed name or alias (other than a screen name where a contest involves use of a social media site). The Contest is subject to all applicable federal, state, and local laws and regulations. Participation in the Contest constitutes the entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest.
3. **CONTEST PERIOD.** The Contest will begin April 1, 2025, at 7:00 AM CST and end May 4, 2025, at 12 PM CST. The Sponsor’s office computer is the official time keeping device for the Contest.
4. **CONTEST PRIZE:** One grand prize winner will receive gift cards to the grocery chain of their choice, subject to gift card availability, equaling a value of \$3,000 calculated on \$500 per month for six months. Winner is responsible for all taxes, including federal, state, local, income, use, and sales taxes, associated with prize receipt and/or use. Sponsor reserves the right to issue tax documentation to any applicable taxing authorities in such manner and at such time as may be determined by Sponsor in its sole discretion. Sponsor is not responsible for changes in applicable tax law or regulation and will not revise prize award terms due to changes in law or regulation except in its sole discretion. Sponsor reserves the right to substitute any listed prize for one of equal or greater value for any reason.
5. **CONTEST ENTRY.** Requires a demo of a John Deere 1-4 series tractor at TriGreen and a qualified entry. 1 entry per demo per person. Purchasing a John Deere 1-4 series compact utility tractor with a signed purchase order within the giveaway period qualifies an individual for 10 additional entries which will be applied automatically prior to the drawing.
 - a) **To enter:** Upon the conclusion of the demo, a TriGreen Equipment Sales Professional will complete a digital form with registrant information including name, type of test drive, and contact information. The registrant will receive an automated email containing an entry form which must be completed by the end of the Contest period. If eligible, the registrant will receive (1) entry into the giveaway pool.

- b) Additional entry method: During the giveaway period, visit any TriGreen Equipment location and test drive a 1-4 series John Deere compact utility tractor. Upon the completion of the test drive, a TriGreen Sales Professional will provide you with an entry form that must be completed in its entirety to qualify as an entry.
 - c) To increase entries: During the Contest period, any qualifying registrant who completes a purchase of a 1-4 series John Deere compact utility tractor will automatically be granted (10) additional entries into the giveaway pool.
6. **WINNER SELECTION.** Sponsor will select one (1) potential prize winner at random from among all eligible entries assigned to the Entry Pool. Potential winner and eligibility are subject to verification by Sponsor or its Administrator, whose decisions are final in all matters relating to the Contest. Drawing will take place in Athens, AL, and will be conducted by Sponsor or its Administrator. One winner will be selected the week of May 12 2025 – May 16 2025. The winner will be contacted via phone call, text, or email. Odds of winning a Contest prize depend on a number of factors, including but not limited to, the number of eligible entries received by Sponsor during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and will be awarded the prize subject to verification of eligibility and compliance with the terms of these rules or the specific Contest rules. Sponsor's decisions as to the administration and operation of Contests and the selection of potential winners are final and binding in all matters related to the Contest.
